Authors willing to submit the manuscript for potential publication in OJPAS®, shall ensure that the manuscript submitted for review is a bonafied record of their own genuine works, not submitting the works of other authors, i.e. violating the copyright act and has not even been submitted for review to any other publishing agency. The Editorial Board of the journal will support quality control of the contents and improvement of the journal standards. Apart from that, deals with compliance, adherence, and conflict of interest.

OJPAS® is Open Access Journal. The journal adheres to the Budapest Open Access Initiative (BOAI) definition of open access: that users have the right to "read, download, copy, distribute, print, search, or link to the full texts of these articles". The journal offers 'Platinum' open access model. Platinum open access model means that there is no Article Processing Charge (APC), also known as publication fee, charged to authors and articles are immediately available on the journal website once published. ## **Review Process**

- 8. The decision letter is sent to the author.
- 9. The accepted article will be published online after receipt of the corrected proof and the disclosure of potential conflicts of interest form (the ICMJE Conflicts of Interest form available from: http://www.icmje.org/conflicts-of-interest/). This service has been designed to ensure the earliest possible circulation of research papers immediately after acceptance. This is the first publication citable. After the release of the printed version, the paper can also be cited by issue and page numbers.
